Statistical units are also the units of the enterprises that produce industrial products, and its parent company does not belong to industrial sectors but in forestry, construction and the like. Business entities which industrial activity is performed on the territory of two or more municipalities are divided into the statistical units as there are municipalities on which territory the business entities are practicing.

Errors in processing: In the application for processing are implemented rules for controls and calculations of output.

Errors in non-response: Reporting units that do not submit a report within the legally prescribed timeliness are contact by telephone. Also reporting units that submitted reports incompletely, are contacted by telephone in order to provide the requested information. If the reporting units that are already included in the monthly survey IND.1 did not submit data imputation of production obtained with the monthly report from the previous year is performed.

## 18 Statistical processing

### 18.1 Source data

This statistical survey is a sample survey. The sample is selected from the Statistical Business Register of the enterprises that are active and submitted Annual accounts and are registered in sectors B - Mining and quarrying, C - Manufacturing, D - Electricity, gas, steam and air conditioning supply and E (division 38) - Waste collection, treatment and disposal activities; materials recovery from National classification of activities - NKD Rev. 2. Sample for ""Annual Report of Industry"" (IND.21) covers 85% of gross value added in industry in 2020 and the data sources are accounting and personnel records and documentation available at the reporting unit. Updating of the sample is carried out annually. The sample in 2021 covered 1350 businesses.

### 18.2 Frequency of data collection

Annually.

### 18.3 Data collection



In the data collection process the reporting method is used. The reporting units send the annual questionnaire for industry IND.21 to the statistical regional offices within specific period of time, for the reporting year. Companies themselves fill the data on production, stocks of finished products and sales of finished products to domestic and foreign markets, and submit them to SSO no later than 15.04. in the current year for the previous year.

#### **18.4 Data validation**

The results from Annual survey for industry IND.21 are compared with the results from the Monthly survey for industry IND.1 . Verification of data is done in accordance with the defined control criteria. Authentication data is performed before and after the entering. For deviations are contact the respondents.

#### **18.5 Data compilation**

Editing: The received data from businesses, after the verification and eventual correction in consultation with the reporting units are entered on an electronic medium by application with incorporated on-line controls.

Imputation: If the reporting units that are already included in the monthly research IND.1 did not submit data, imputation of production obtained with the monthly report from the previous year is performed.
